# PIRATE PLUNDER ADVENTURE RACE WAIVER

- \_\_\_\_\_ 1. I understand that entering Pirate Plunder Adventure Race is a hazardous activity.
- \_\_\_\_\_ 2. I understand that Pirate Plunder Adventure Race presents extreme obstacles including, but not limited to, water obstacles, mud pits and steep hills.
- \_\_\_\_\_ 3. I agree not to participate unless I am medically able.
- \_\_\_\_\_ 4. I agree to not consume alcohol prior to and/or during the Pirate Plunder Adventure Race or ingest any medicines or substances that will inhibit my mental or physical ability to safely and effectively participate in Pirate Plunder Adventure Race.
- \_\_\_\_\_ 5. I agree to abide by any decision of a race official relative to my ability to safely complete the race.
- \_\_\_\_\_ 6. I agree to obey all civil and criminal laws at all times.
- \_\_\_\_\_ 7. I agree that **Pirate Plunder Adventure Race** is not responsible for any personal items or property that are lost or stolen in the gear check area.
- \_\_\_\_\_ 8. I consent to emergency medical care and transportation in order to obtain treatment in the event of injury to me as medical professionals may deem appropriate. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency.
- \_\_\_\_\_ 9. I understand and will abide by the rule that no wheeled baby conveyances or other wheeled means of conveyance, or pets are permitted in the race.
